




## DUKE LAW

**IN A WORLD OF INTERNATIONAL INTERACTION**, cross-border transactions, and global competition, lawyers are called upon to master not only their own legal systems, but also international law and the law of other nations. The Duke-Geneva Institute in Transnational Law is designed to help you prepare for successful work in this increasingly international legal landscape. Through a four-week, intensive program, the institute provides educational and professional tools for students and young lawyers who are interested in international and comparative law and aim to pursue or expand a transnational legal practice.

**The Summer Institute in Transnational Law**

is more than an educational program. It offers distinctive transnational, transcultural experiences centered on a collaborative study of law and the economic, political, and social challenges that confront today's lawyers.

## RESIDENTIAL PROGRAM

Students and faculty live in a collegial residential site, offering opportunities for cross-cultural exchange and learning that extend far beyond the classroom.



## COMPARATIVE LEGAL ANALYSIS

Each course is taught in a comparative framework by professors from different legal traditions, offering a unique opportunity to analyze legal questions from a transnational perspective.

## CLOSE FACULTY-STUDENT INTERACTION

Course sizes are small, facilitating close faculty-student interaction and strong friendships among all participants.



# GLOBAL STUDENTS

Students come from around the world — among the participants are Duke Law JD and JD/LLM students; JD students from other American law schools; international students who will soon embark on LLM programs; law students from the host university and from other law schools; and legal professionals from a wide variety of law firms and legal institutions.

## LEARNING BEYOND THE CLASSROOM

The institute takes full advantage of the unique economic, political, and historical features of Geneva, with visits to and meetings with local law firms, businesses, and international organizations, as well as a variety of cultural and social events.

### Who should apply?

The Duke Law Summer Transnational Institute is designed for JD students who have completed at least one year of law school, students who will join LLM programs at American law schools, and for advanced law students, judges, and teachers of law from around the world. International students who want to experience U.S. legal education and practitioners who are unable to leave their positions for an entire academic year to take an LLM degree find the institute a valuable experience.

### How much does it cost?

The fee for hotel accommodations, activities, and meals is listed on the website. Tuition for the institute is \$4,850 (local lawyers may enroll in a single course only for a reduced cost; see the website for details). The non-refundable registration fee is \$350.

### Can I get academic credit at my law school?

American law students, and in some cases students from other countries, normally can receive academic credit from their home institutions. Students are responsible for obtaining approval from their own law schools to transfer credit. Students who do not wish to receive academic credit are not required to take final examinations. The institute is part of the accredited curriculum of Duke Law School and is accredited by the American Bar Association.

### IN THE CLASSROOM AND BEYOND

Thanks to a 20-year partnership with the University of Geneva Faculty of Law, the Duke-Geneva Institute in Transnational Law is wholly integrated into the life of its home city. Classes are held at the University of Geneva in spacious, modern facilities and are taught in English. Courses meet on weekdays from 8:30 a.m. to 3:35 p.m. and are divided into two two-week terms, each taught by a faculty member from a different legal culture to expose students to comparative law studies and differing teaching

approaches. In addition to the academic courses, the institute features a series of special presentations offered by legal practitioners held in conjunction with visits to organizations and government offices in Geneva. And when classes are over for the day, you'll find a wide range of social activities that will enhance your relationships with students and faculty and make your four weeks in Geneva one of the best experiences of your academic career.

### About our partner

The University of Geneva Law Faculty has a well-established tradition of scholarship that dates back to the 16th century. In addition to a strong core curriculum, the Law Faculty excels in international and cross-border law and is home to several centers specializing in financial law, European law, art law, children law, humanitarian law, and legislation techniques, as well as a training center for future lawyers. Degree programs include the Bachelor of Laws, three Master of Laws programs, four LLM programs, seven Certificate of Advanced Studies programs, and a doctoral program.
